8 Consultants brief

Impact Assessment in Priority Wards through Neighbourhood Renewal.

1. Background

- 1.1. The Neighbourhood Renewal Programme in Hastings and St Leonards has been operating from April 2001. Last year further funding was granted for an additional two years until March 2006.
- 1.2. March 2004 will complete the third year of the Neighbourhood Renewal Programme in the five priority wards of the Borough (one of these wards, Hollington, operates under the Neighbourhood Management Pathfinder programme). During this time the Local Neighbourhood Renewal Strategy (LNRS) has been set out and the NRF has been used to fund the key strands of the strategy.
- 1.3. As the responsible authority, Hastings Borough Council together with its partners, now wish to examine the impact of the last three years work on the priority wards against the floor targets. As well as the impact on the priority wards, there is a need to identify the 'good practice' emerged through Neighbourhood Renewal, and the sustainability of the programme beyond the NRF term.

2. Areas for impact assessment

- 2.1. In order to carry out the 'impact assessment' we are seeking a competent, independent consultant to analyse what is currently being done in line with the LNRS and to recommend improvements and sustainability particularly in the following areas:
 - The thematic support provided through NRF
 - Voluntary sector engagement through NRF
 - Local structures (ward Fora and Local Management Boards) and monitoring set up under the LNRS
 - Service planning (Local Action Plans) within the five priority wards
 - Performance, and the sustainability of the Local Management Boards
 - Impact so far from the Local Learning Plan

3. Parameters

3.1. The assessment has to be done within the newly recommended Performance Management Framework, and the engagement of the partners working within the Neighbourhood Renewal Programme.

- 3.2. The study must be informed by face-to-face interviews with partner agencies and case studies as well as statistical information relevant to the strands identified above.
- 3.3. The information provided by the statement of use has to be taken into account as part of the study.
- 3.4. A definite understanding of the results Neighbourhood Renewal has had on the priority wards against the floor targets.
- 3.5. The study should identify the opportunities and challenges offered by the Hastings and Bexhill Task Force regeneration programme and Area Investment Framework in relation to sustaining NR in Hastings and St.Leonards beyond the life of Neighbourhood Renewal Funding.

4. Essential Outcomes

- 4.1. The study should:
 - Identify current deficits in the areas outlined under section 2.1
 - Clearly identify outcomes with regard to section 3.4
 - Recommend the sustainability of the structures beyond the Neighbourhood Renewal period taking into account section 3.5
 - Recommend the ways and means of enhancing mainstreaming opportunities
 - Identify barriers in extending good practice throughout the priority wards, in particular, the gains that have been made within the Neighbourhood Management Pathfinder in Greater Hollington and recommend ways to improve the current situation.
 - Recommend ways of achieving better engagement of BME communities and other harder to reach groups, including young people in the priority wards within the Neighbourhood Renewal process.

5. Personal Specification

5.1. We need a professional who has a good understanding of and experience in evaluating interventions in Neighbourhood Renewal. The person must have a good understanding how Neighbourhood Renewal Strategies can make an impact in delivering the community strategy. Local knowledge is a distinct advantage.

6. Timescale

6.1. The study must be completed within two months, starting from the end of February 2004. A draft report must be submitted for consultation purposes at the end of March and a final report will be due by the end of April.

7. Funding

7.1. The work will be funded through Neighbourhood Renewal Funding and £8K has been provisionally allocated for this purpose.
