

1.1 ABOUT THIS REPORT

- 1.1.1 This background report sets out the results of the second phase of public consultation on White Rock Gardens which took place in July 2002. It should be read in conjunction with the Masterplan 2002, submitted to Hastings Borough Council by the consultants for formal consideration.
- 1.1.2 The Masterplan is based on the results of two phases of public consultation. The consultants have incorporated as many of the ideas put forward as possible in a programme of short, medium and long term improvements.

1.2 THE CONSULTATION PROCESS

- 1.2.1 The first phase of public consultation took place in February 2002 and involved over 200 people taking part in two Community Design Days and 116 people submitting written or drawn suggestions in response to a consultation flyer. The results are contained in a separate report entitled 'Background Report on first phase of Public Consultation, February 2002'.
- 1.2.2 This was used as a basis for drawing up a Draft Masterplan. The second phase of public consultation took place in July 2002 and involved seeking comments on the Draft Masterplan. The plan was published as a pull-out feature in the summer issue of the Council's *About* Magazine which is distributed to all households in the Borough. The feature was in the form of a reply-paid questionnaire and contained a listing of the objectives and proposals (see Appendix). People were asked to use tick boxes to indicate whether they agreed, disagreed or had no opinion on each of the proposals and space was provided for making additional comments on each objective and on the plan as a whole.
- 1.2.3 A letter was sent out to all those who had taken part in the first round of public consultation drawing attention to the feature in *About* magazine. A press release was also issued to remind people to respond.

1.3 THE CONSULTATION RESPONSE

- 1.3.1 A total of 110 completed questionnaires were returned.
- 1.3.2 No personal details were requested from respondents but it would appear from the comments that all the existing sporting and other main interest groups using the Gardens were well represented. Reponses were also received from a range of age groups and from people in different parts of the Borough.
- 1.3.3 It is clear from the returned questionnaires that people have generally understood the proposals and have reacted thoughtfully to them. Only a handful of forms display evidence of people championing one particular cause. Only a handful of people declined to complete their names and addresses.
- 1.3.4 It is therefore considered that the response can be treated as reasonably representative of the views of the current users of the Gardens and residents of the Borough in general.

1.4 CONSULTATION FINDINGS SUMMARY

- 1.4.1 There is a good measure of agreement on the eight objectives proposed, subject only to a general feeling that the big draw should be not be too big or too commercial and that the landmark building should also not be too large.
- 1.4.2 There is a good measure of agreement on all of the proposals put forward apart from the helter skelter and roller coaster suggestions for a big draw. The preference was for a draw involving water, plants or sports. The Masterplan has been changed accordingly.
- 1.4.3 There is concern by some about the proposals to site facilities at the north side of the Oval (BMX/MTB track/trail and Amphitheatre). Alternative possible locations for each of these facilities are therefore suggested for consideration at feasibility stage.
- 1.4.4 A large number of useful comments and suggestions have been made and it has been possible to revise the Masterplan to incorporate most of them. It would however be worth reviewing them again at feasibility stage. It would also be worth reviewing the detailed suggestions made during the first phase of consultation at the same time.
- 1.4.5 The general response to the Draft Masterplan has been extremely enthusiastic as can be seen from the quotes set out in para 2.10 as well as the high level of support for the individual proposals.

1.5 WAY FORWARD

- 1.5.1 The revised Masterplan would appear to provide a sound basis on which to proceed.
- 1.5.2 Following formal approval by Hastings Borough Council, detailed feasibility and design work will be needed to firm up specific proposals and make choices between the options presented.
- 1.5.3 The Covenants on the land need to be checked by the Borough Solicitor to ensure that the proposals do not conflict with them.
- 1.5.4 The Masterplan could perhaps form the centrespread of a newsletter on White Rock Gardens updating people on progress.
- 1.5.5 The Masterplan should perhaps be revised and updated annually as feasibility and design work proceeds.

The questionnaire comprised the proposals listed under 8 objectives (see Appendix). Tick boxes were provided for both objective s and the activities proposed to achieve them. In practice most people only completed the latter.

This section contains the text of the questionnaire with analysis of the votes cast. Additional ideas and comments for each objective are summarised after the analysis. General comments are then summarised with endorsements recorded as direct quotes at the end.

Improving White Rock Gardens

White Rock Gardens is the second largest park in Hastings and St Leonards and will be celebrating its centenary in 2004. Now there is an opportunity to improve this important area.

Hastings Borough Council has allocated £200,000 to improve the west side of the Gardens. In addition money has been set aside to replace the indoor bowling centre. With a new University planned for central Hastings, there may be other possibilities for attracting funding with the right ideas.

The Council is therefore preparing a Masterplan for the Gardens to ensure that the most is made of the opportunities and is keen to ensure that this reflects local views.

Building on success

The draft proposals in this document are based on feedback from over 200 people who attended two Community Design Days in February and 116 who submitted suggestions in writing or drawings.

Eight main objectives have been identified from this first round of public consultation, and over 50 detailed proposals for achieving them. These range from fairly simple improvements which could be implemented quite soon, to more visionary ideas which will need further investigation and fund raising.

The overall strategy is to build on and develop the many successful things already happening, at the same time as exploring a range of new initiatives designed to realise the tremendous potential of the area during the Gardens' second century.

- Have another look round the Gardens and imagine what it might be like;


- Make your views known before the end of July. The Masterplan will then be revised and considered formally by the Council as a basis for future action.
