# Community Planning in Conflict Zones

Standard post-war rehabilitation programming often involves international donor and implementing agencies working with national authorities to develop macro-level recovery strategies. While much has been written on the need for participatory approaches, most programmes continue to be based on externally driven, top-down strategies.

**This training seminar** provides an overview of a methodology for community-led rehabilitation developed by the International Federation, the World Bank and the Post-war Reconstruction and Development Unit of the University of York in response to a number of conceptual, programming and

structural barriers to effective rehabilitation in post-conflict situations. In collaboration with the Somalia Red Crescent, the methodology was tested for the rehabilitation of the health sector in the Puntland state of Somalia in 2000.

The seminar is designed for practitioners and academics working in the fields of humanitarianism, post-war recovery, development studies and disaster management.

**Participants will learn** about the challenges and opportunities of using community-led approaches in war-affected countries such as Afghanistan, Bosnia Herzegovina, Croatia, Indonesia, Kosovo, Lebanon, Somalia, Sri Lanka and Yemen.

**Sultan Barakat** is Director of the **Post-war Reconstruction and Development Unit** (PRDU) of the University of York, UK.

**Alpaslan Özerdem** is a Lecturer at the PRDU.

They both have extensive teaching and research experience in issues related to humanitarianism, strategic planning of post-war reconstruction, and post-war recovery.
